

Subacute Rehabilitation

Subacute rehabilitation takes place in a **Skilled Nursing Facility (SNF)** – a place like a nursing home that gives special medical care after people leave the hospital. On the next page, you'll see a list of SNFs near Atlantic Health System hospitals where you can get this kind of care.

Picking the Right Place

- **You can choose** the SNF you want to go to, as long as they can care for you and have a bed open.
- Your care team will usually ask for your **top three choices**, just in case your first pick is full.
- To help you choose, Atlantic Health System has chosen a special group of SNFs that are doing a good job caring for patients. This group is called the **High Performing Network (HPN)**.





What is the High Performing Network (HPN)?

- SNFs in the HPN have to meet certain criteria. We make sure they take care of patients the right way, for the right amount of time, and don't send people back to the hospital unless necessary.
- These SNFs are connected to our computer system, so your health information can be shared quickly. This helps you get care faster.
- We check on these SNFs every six months and talk with them often.
- We have special nurses who work with our HPN facilities. They help make sure you're getting good care. They may visit you or leave notes in your health chart to share with the rest of your care team.
- If you stay at an HPN SNF and have a question or concern, you or your family can call our Concierge Line at 973-829-4594. Someone will usually call you back in one to two business days.

About Centers for Medicare & Medicaid Services (CMS) Star Ratings for SNFs:

- The Centers for Medicare & Medicaid Services (CMS) give star ratings to each SNF. The **Overall Star Rating** is based on:
 - How well patients are cared for
 - Health and safety checks
 - How many nurses are working
- One part of the rating is called the **Quality of Resident Care Star Rating**. It looks at facts and numbers to show how well patients are treated. That is the rating used on this list.
- The ratings on this list are up to date as of **August 29, 2025**, but ratings can change. To find the newest ratings, go to [medicare.gov/nursinghomecompare](https://www.medicare.gov/nursinghomecompare).
- CMS gives these ratings to help you, your family, and caregivers compare facilities more easily. CMS suggests using star ratings along with other helpful information when choosing the best SNF for you or someone you care about.



What You Need to Know About Medicare and Nursing Home Care

Medicare is health insurance from the government. It helps pay for some of your care. If you need short-term care in an SNF, Medicare Part A might help pay for it, but certain rules have to be followed.

Here is what needs to happen for Medicare to help pay:

- You have **Medicare Part A** and still have days left to use it.
- You stayed in a hospital for at least **three full days in a row** (not counting the day you leave).
- You go to the SNF **within 30 days** after leaving the hospital.
- A doctor says you need **daily medical care**, like therapy or medicine through an IV.
- The care you get must be from trained nurses or staff.
- You must go to an SNF that **accepts Medicare**.
- You need this care because:
 - You're still being treated for something you had while in the hospital, or
 - You got a new health problem while being treated in the SNF.
- The care must help you **get better, stay the same, or keep from getting worse**.

What Will It Cost?

If you have **Original Medicare**, here is what you pay in each benefit period:

- **Days 1 - 20:** \$0 (free)
- **Days 21 - 100:** You pay \$209.50 each day.
- **After 100 days:** You pay everything yourself.

Your doctor might suggest extra care that Medicare doesn't pay for. If that happens, you might have to pay some or all the cost. Make sure you ask questions so you understand what's being recommended and how much you might owe.

If You Have a Medicare Advantage Plan

If you're in a **Medicare Advantage plan** (a private version of Medicare):

- You'll need to use a SNF that's in your plan's network.
- Your discharge team will work on getting approval from your plan for your chosen facility.
- Your plan might also have different costs. Call your plan to learn more.
